# CA MOCK TRIAL FINALS

#### Notes/Disclaimer

The registered team members participating in the 2025 state finals must be the same registered team members that participated at the county level competition. See rule below. Rule 2.1 — Team Eligibility

No new team members may be added to a team after the county registration leadline. This also applies to individual teams from counties where two teams per school are allowed. Team members must remain in the designated registered team, with no substitution between the two teams. Teams representing a county at the state finals must be composed of students who registered and part fipated on the current county-winning team.
